WOMEN'S HEALTH CONNECTION REIMBURSEMENT SCHEDULE FY26			
- Reimbursement rates are based on Nevada's maximum allowable Medicare rates. The total payment is not to exceed the approved rates. - If the provider bills less than the approved rate for a service, the provider will be reimbursed at the billed amount. - The provider must accept Medicare's reimbursement rates as payment in full for services rendered. Balances may not be billed to the patient. - Providers are encouraged to give WHC patients a written estimate of any additional charges that are not covered under the program prior to the procedure. - Providers are encouraged to write off charges not reimbursed by WHC. - A surgical center (modifier SG) is a distinct entity that operates exclusively to furnish surgical services to patients who do not require hospitalization, in which the expected duration of services does not exceed 24 hours following admission. - A surgical center is not the same as a provider-based outpatient surgery center. Procedures and services performed in a provider-based outpatient surgery center should be billed using the non-facility fee. - If a provider performs a service or procedure at an ASC, the provider would be entitled to the professional rate (modifier 26), and the surgical center would be entitled to the facility fee (modifier SG). - If a provider performs a service or procedure in their office, the provider would be entitled to the Global rate. - Global fees and SG fees cannot be billed together. - All billing claims must indicate an associated ICD-10 code for reimbursement.			
A new patient is a patient new to WHC, or a patient who has NOT been seen by a WHC provider or practice within the last three (3) years. An Established Patient is a patient who has been seen by the provider or practice within the last three (3) years. All consultation visits should be billed through the standard "new patient" office visit CPT codes, 99201-99205.

These codes (99204–99205) are typically not appropriate for NBCCEDP screening visits. However, they may be used when provider spends extra time to do a detailed risk assessment.
2	The 9938X codes shall be reimbursed at or below the 99203 rate, and 9939X codes shall be reimbursed at or below the 99213 rate. The type and duration of office visits should be appropriate to the level of care needed to accomplish screening and diagnostic follow-up within the NBCCEDP.
